Diggs v. Schultz is a lawsuit brought by the Center for Constitutional Rights (CCR) to invalidate the Byrd Amendment. It was brought on behalf of the Black Congressional Caucus and other groups, including Zimbabwean exiles in this country. In flagrant violation of a United Nations Security Council resolution which it had supported, establishing an embargo on trade with Southern Rhodesia (Zimbabwe), Congress passed a special resolution (the Byrd Amendment) permitting the United States to ...
