CRIMINAL PROCEDURE CODE OF GEORGIA LAW OF GEORGIA

The State indicted appellee Jerry Sutton for malice murder in connection with the shooting of his brother-in-law, William Anderson. The trial court granted Sutton's motion to dismiss, finding that appellee acted in self-defense, and thus immune from prosecution under OCGA 16-3-24.2. The State appealed, arguing the trial court erred in granting the motion to dismiss the indictment.

Upon any motion for summary judgment pursuant to the Georgia Civil Practice Act, there shall be annexed to the notice of motion a separate, short and concise statement of each theory of recovery and of each of the material facts as to which the moving parts contends there is no genuine issue to be tried.

Wells Fargo Bank, N.A., Case No. A13A2373 (decided April 18, 2014), the Georgia Court of Appeals reversed the dismissal of a complaint and relied upon the same minimal standard: [I]t is not necessary for a complaint to set forth all of the elements of a cause of action in order to survive a motion to dismiss for failure to state a claim.
