Datasets available include LCSH, BIBFRAME, LC Name Authorities, LC Classification, MARC codes, PREMIS vocabularies, ISO language codes, and more.

The subject access request must be completed without undue delay and at least within one month. The timescale can be extended up to two months if the request is complex and or the individual has made numerous requests. Any extension and the reason for the extension should be communicated in writing before the initial one month expires.
