Ohio Rules of Court - Supreme Court of Ohio

Section 1. Board of Professional Conduct of the Supreme Court. There is created under Rule V of the Supreme Court Rules for the Government of the Bar of Ohio a Board of Professional Conduct of the Supreme Court. The Board shall receive evidence, preserve the record, make findings, and submit recommendations to the Supreme Court as follows:
