Regulatory Law Social work practice also is governed by many regulations promulgated by federal and state government agencies, such as the U.S. Department of Health and Human Services and state human service, child welfare, and mental health agencies.

“Social work and the law” refers to the interface between the practice of social work and the legal system, including statutory law, case law, legal institutions (courts, prisons, etc.), and legal professionals (attorneys, judges, paralegals, forensic experts, and alternative dispute resolution professionals).

The North Dakota Board of Social Work Examiners [Board] was formed in 1983 by the legislative assembly. It is a six-member board appointed by the governor. The Board is responsible for licensing qualified applicants to practice social work and to ensure that licensees comply with the laws and regulations governing that practice.
