As public records, contract forms adopted by the Texas Real Estate Commission are available to any person. Real estate license holders are required to use these forms. However, TREC contract forms are intended for use primarily by licensed real estate brokers or sales agents who are trained in their correct use. Mistakes in the use of a form may result in financial loss or a contract which is unenforceable.

Historically, Texans (as well as other Americans) could freely buy and sell rights in real estate purchase contracts and real estate option contracts. That is, they could freely engage — without a real estate license — in the business of real estate wholesaling.

There is no similar place for the brokers or the parties to insert such a date in the commercial contracts. The commercial contracts address the matter of the effective date in paragraph 24.

### **OFFICIAL Texas Residential Purchase Agreement [2020]**

LICENSE HOLDER DISCLOSURE: Texas law requires a real estate license holder who is a party to a transaction or acting on behalf of a spouse, parent, child, business entity in which the license holder owns more than 10%, or a trust for which the license holder acts as a trustee or of which the license holder or the license holder's spouse, parent or child is a beneficiary, to notify the other party in writing before entering into a contract of sale.

TREC rules require a license holder to provide the Addendum for Sale of Other Property by Buyer to a buyer who wants to make a contract contingent on the sale of another property.
