Lemon Law for the Consumer Connecticut was the first state to put a “Lemon Law” in place to help owners of defective vehicles at or under 2 years old or with a mileage of 24,000 or less. The Lemon Law program has returned more than \$60 million in refunds and replacement vehicles to Connecticut consumers.

CONNECTICUT LEMON LAW

Connecticut's statutes look a lot like lemon laws in other states: the dealer must replace the car or refund the purchase price (and collateral charges) if the vehicle cannot be repaired within the first two years or 24,000 miles. Lemon Laws in Connecticut

The Connecticut lemon law provides consumers with aid after the purchase of a lemon vehicle. In order for a vehicle to be considered a lemon, it must have significant mechanical failings that affect the use, safety and value of the vehicle. Furthermore, the vehicle must fail numerous repair attempts by the vehicle's manufacturer.

New Vehicle Lemon Law Program. The "Lemon Law" is a nickname for a program created by Connecticut General Statute Chapter 743b, "Automotive Warranties." Under the law, the arbitration program is an informal process for resolving disputes between consumers and automobile manufacturers. Each year, dozens of consumers are awarded new cars or refunds through the arbitration program.

2 years or 18,000 miles. Connecticut consumers with lemon vehicles may be protected under either the Connecticut Lemon Law, the Magnuson-Moss Warranty Act (the federal lemon law), or both. Remedies may include refund, replacement or cash compensation such as diminished value and/or incidental and consequential damages.

The law defines a lemon as a new motor vehicle (passenger car, combination passenger/commercial van, truck or motorcycle) purchased or leased in the Connecticut which does not conform to the

CONNECTICUT (CGS §§ 42-220 TO 42-226A)
Connecticut's "Used Car Lemon Law" was adopted in 1987. Although amended several times, its major provisions have remained substantially unchanged. It requires motor vehicle dealers to provide express warranties to consumers who buy used cars costing \$3,000 or more.

What the Connecticut Lemon Law Covers In order for your vehicle to qualify as a lemon in Connecticut, it must be a new passenger, combination passenger/commercial or motorcycle vehicle that was either purchased or leased in Connecticut. The defects must be substantial and affect the use, safety

Connecticut Lemon Law - Did You Purchase or Lease A Lemon ...

The Connecticut Lemon Law applies to passenger vehicles, commercial vehicles, and motorcycles purchased and leased in Connecticut which suffer a nonconformity – a defect or condition which substantially impairs the vehicle's use, value, or safety – that cannot be repaired within four (4) attempts by an authorized manufacturer's dealership.

Connecticut Lemon Laws - FindLaw

Under Connecticut's Lemon Law, auto manufacturers are required to replace the vehicle or buy it back if they are unable to repair the vehicle after a reasonable number of attempts. Generally, if a vehicle cannot be fixed after four attempts, the manufacturer will likely have to replace the vehicle or buy it back from the consumer.

The Connecticut lemon law sets out the following amounts that a manufacturer must pay when it repurchases a motor vehicle under the lemon law: 1. The full contract price of the vehicle, including...

The lemon law offers protections for a new vehicle when (1) the same defect has been the subject of repair attempts four or more times during the first 24,000 miles or two years of service, (2) it has been out of service for repair for a cumulative total of 30 days during the same period and the defect continues to exist, or (3) the same safety-related defect has been the subject of repair two or more times in the first year or twice within the warranty period, whichever comes first.
